This Cookies Privacy Policy applies to FINYX (CYPRUS) Investments Ltd which has a registered office at Arch. Makariou III, 172, MELFORD TOWER, 2nd floor 3027, Limassol Cyprus website, branded pages on third-party platforms (such as Facebook), and applications accessed or used through such websites or third-party platforms.

FINYX (CYPRUS) Investments Ltd may use cookies to obtain information about you while visiting our websites. A cookie is a very small text file that is sent to your browser from a web server and stored on your computer's hard

drive. It assigns the computer with a unique identifier, which in turn, becomes your identification card whenever you return to FINYX (CYPRUS) Investments Ltd website.

Cookies are designed to save you time because they help us provide you with a customized experience without you having to remind us of your preferences each time you return to our web pages. FINYX (CYPRUS) Investments Ltd cookies are not designed to damage your files, nor can they read information from other files on your computer hard drive.

Cookies can also help us provide you with a personalized on-line experience in the following ways:

- o they remember your user name and password for future visits so log-in is easier and faster
- o they ensure you are provided with the appropriate frames and content
- o they ensure you obtain all requested information
- o they help us deliver communications that are relevant and responsive to your interests and location.

By using FINYX (CYPRUS) Investments Ltd, you are consenting to our use of cookies in accordance with this Cookie Notice. 1 What are cookies?

A cookie is a simple text file that is stored on your computer or mobile device by a website's server, and only that server will be able to retrieve or read the contents of that cookie. Each cookie is unique to your web browser. It will contain some anonymous information, such as a unique identifier and the site name and some digits and numbers. It allows a website to remember things like your preferences for browsing that site.

2 What to do if you don't want cookies to be set

Some people find the idea of a website storing information on their computer or mobile device intrusive, particularly when this information is stored and used by a third party without them knowing. If you prefer, it is possible to block some or all cookies, or even to delete cookies that have already been set; but you need to be aware that you might lose some functions of that website.

3 Type of Cookies

3.1 First-Party Cookies

First-party cookies are set by the website you are visiting, and they can only be read by that site.

3.2 Third-Party Cookies

Third-party cookies are set by a different organization to the owner of the website you are visiting. For example, the website might use a third-partyanalytics company that sets their own cookie to perform this servic(e.g., Google). The website you are visiting may also contain content embedded from a third-party site, and these sites may set their own cookies.

FINYX (CYPRUS) Investments Ltd does not track your browsing after you leave the site.

FINYX (CYPRUS) Investments Ltd website may also include elements that set cookies on behalf of a third party (e.g., a "like" button from Facebook or a "tweet" button from Twitter).

3.3 Session Cookies

Session Cookies are stored only temporarily during a browsing session and are deleted from the user's device when the browser is closed.

3.4 Cookies Used on FINYX (CYPRUS) Investments Ltd website

Type of Cookie	What do they do?	Do these cookies collect my personal data/identify me?
Necessary	These cookies are essential to make FINYX (CYPRUS) Investments Ltd website work correctly. They enable you to move around our websites and use our features. Examples include remembering previous actions (e.g., entered text) when navigating back to a page in the same session.	These cookies don't identify you as an individual. If you do not accept these cookies, it may affect the performance of the website or parts of it.
