This Cookies Privacy Policy applies to FINYX (CYPRUS) Investments Ltd which has a registered office at Spyrou Kyprianou Ave 17 Limassol, 4001 Cyprus **website, branded pages on third-party platforms (such as Facebook), and applications accessed or used through such websites or third-party platforms.**

FINYX (CYPRUS) Investments Ltd may use cookies to obtain information about you while visiting our websites. A cookie is a very small text file that is sent to your browser from a web server and stored on your computer's hard drive. It assigns the computer with a unique identifier, which in turn, becomes your identification card whenever you return to **FINYX (CYPRUS) Investments Ltd** website.

Cookies are designed to save you time because they help us provide you with a customized experience without you having to remind us of your preferences each time you return to our web pages. **FINYX (CYPRUS) Investments Ltd** cookies are not designed to damage your files, nor can they read information from other files on your computer hard drive.

1 What are cookies?

3 Type of Cookies

3.1 First-Party Cookies

First-party cookies are set by the website you are visiting, and they can only be read by that site.

3.2 Third-Party Cookies

Third-party cookies are set by a different organization to the owner of the website you are visiting. For example, the website might use a third-party analytics company that sets their own cookie to perform this service (e.g., Google). The website you are visiting may also contain content embedded from a third-party site, and these sites may set their own cookies.

FINYX (CYPRUS) Investments Ltd does not track your browsing after you leave the site.

FINYX (CYPRUS) Investments Ltd website may also include elements that set cookies on behalf of a third party (e.g., a “like” button from Facebook or a “tweet” button from Twitter).

3.3 Session Cookies

Session Cookies are stored only temporarily during a browsing session and are deleted from the user’s device when the browser is closed.
